
In G.O.(MS)No.152 Health and Family Welfare (P1) Department,  
dated: 23.03.2020, Infection Prevention and Control Regulations for COVID-19  
have been notified.

2. In this regard, the following clarifications are issued.

- i. In para 4(C), (vi) Financial Services included insurance services.
- ii. In para 4(D) (iii), it is clarified that continuous process industries will include Steel, Refineries, Cement, Foundries, Textiles, Paper, Tyres, Fertilisers, Highly Automated Assembly lines, Electronic Manufacturing, Chemical Industries and Sugar Mills.

- iii. In para 4(D) (iv), it's clarified that industries include Micro, Small and Medium Enterprises as well.
- iv. In Para 4(D) (v), it is clarified that Export units will include their vendors also.
- v. In Para 4(F) (iv), it is clarified that essential public utilities will include industries supplying to Defence & Aerospace, Data Centres, Manufacturers of critical communication equipment.
